## What Is Marriage?



You are probably about to begin one of the most important stages of your life—marriage. Marriage contains unique and interesting potential. As one bright optimist put it, "Marriage is the only game of chance in town where both players can win or both lose!" This manual has been developed to help you remove the risk element from marriage. We trust that as you and your fiance work through this program, your present relationship will be strengthened and enriched as a prelude to an enriching, fulfilling, and growing marriage. We also hope that you will have a much more realistic perception of yourself, your fiance, and your marriage.

Such a pledge endures, not because of the force of law or the fear of its actions, but because an unconditional covenant has been made. A covenant more solemn, more binding, more permanent than any legal contract."

"A system by means of which persons who are sinful and contentious are so caught up by a dream and a purpose bigger than themselves that they work through the years, in spite of repeated disappointment, to make the dream come true."

"... Marriage is a relationship between man and woman intended by God to be a monogamous relationship, intended to be a permanent bond in which many needs are satisfied—the need to love and be loved, the need for deep friendship, for sharing, for companionship, for sexual satisfaction, for children, the need to escape loneliness. Marriage ought to be

a bond of love, reflecting the love Christ has for His people, a bond of sacrificial love where husband and wife have become one, one flesh, a unity.'4

Here is another definition of marriage that you may want to consider. The marriage relationship is a school, a learning and growing environment in which (if everything is as it should be) both partners can grow and develop. The relationship grows along with them. If you can see marriage as an opportunity for growth, you can be satisfied and can satisfy your spouse.

Dr. David Hubbard graphically described the marriage relationship when he said, "Marriage does not demand perfection. But it must be given priority. It is an institution for sinners. No one else need apply. But it finds its finest glory when sinners see it as God's way of leading us through his ultimate curriculum of love and righteousness." Have you ever thought about the purpose of marriage in that light?

Here's another definition of marriage. Consider it carefully, and then talk over your feelings with your partner: A Christian marriage is a total commitment of two people to the person of Jesus Christ and to each other. It is a commitment in which nothing is held back. Marriage is a pledge of mutual fidelity; it is a partnership of mutual subordination. A Christian marriage is similar to a solvent, a freeing up of the man and woman to be themselves and become all that God intends for them to become. Marriage is a refining process that God will use to

have us become the man or woman He wants us to become. Think about it. God will use your marriage for His purpose. He will mold and refine you for your own benefit and for His glory.

You may be thinking that when you marry there will be two individuals involved in that marriage. That is true, but there is a third party who can give an even greater meaning to your individual and married life—that person is Jesus Christ. In what way will the presence of Jesus Christ in your life make a difference in your marriage?

#### Reasons for Marriage

- Marrying on the rebound—you were hurt in a former love relationship and to ease your hurt you immediately choose another.
- 7. Fear of hurting the other person—you're afraid of what will happen to your fiance if you break up even though you know that marriage is not the answer.
  - 8. To escape an unhappy home.
  - 9. Because you are pregnant or your fiance is pregnant.
- 10. Because you have had sex.
  - A few of the positive reasons for marriage:
  - 1. Companionship.
  - To work together and fulfill your own and your future mate's needs.
  - 3. To fulfill sexual needs in the way God intends.
  - Love (an adequate blending of the various types of love, as explained in Chapter 3).
  - 5. Because you are convinced that it is God's will for you to

marry this person.

# Uniqueness and Acceptance in Marriage



Your partner is not you. He or she is other, created in God's image, not yours. He has a right to be other, to be treated and respected as other.

Differences. How do you learn to adjust to the differences in your partner without losing who you are? How do you learn to appreciate another person's uniqueness? How can you learn to live with this person who is so different from you? The question is, "When you marry, do you end up marrying someone who is your opposite or someone who is similar?" The answer is, "Yes." It's both. There will be similarities as well as differences, and you have to learn to adjust to both. Think of it like this: We marry for our similarities. We stay together for our differences

Similarities satiate, differences attract.

Differences are rarely the cause of conflict in marriage; the problems arise from our similarities. Differences are the occasion, similarities are the cause.

The differences may serve as the triggering event, as the issue for debate, but our similarities create the conflict

#### between us.

The very same differences that initially drew us together later pull us apart and still later may draw us near again. Differences first attract, then irritate, then frustrate, then illuminate and finally may unite us. Those traits that intrigue in courtship, amuse in early marriage, begin to chafe in time and infuriate in conflicts of middle marriages; but maturation begins to change their meaning and the uniqueness of the other person becomes prized, even in the very differences that were primary irritants. <sup>6</sup>

Differences abound in marriage. Generally, they can be divided into two types. The first includes those that can't be changed, such as age, race, looks, home, and cultural background. Your personal body metabolism will affect where you want the temperature in the home, whether you wake up bright and eager, ready to face the day, or whether you need an hour to get both eyes focusing. These characteristics cannot be changed.

But the other category includes those differences that can be changed. These include personal habits in the bathroom or at the dinner table, whether you like to get up early and your spouse enjoys sleeping late, or whether one likes going out three nights a week and the other prefers watching television at home.

Think about this, "If you plan to marry it is certain that you have a preconceived fantasy of your ideal mate or the perfect marriage. After a while you will begin to realize that your fantasy and the person you have married will begin to diverge sharply. At that point you may embark upon a reform program, forgetting that only God can make a tree. You misconstrued the

words of the wedding ceremony 'and the two shall become one' to mean that your mate should become like you and your fantasy. You would become one in likes, preferences, interests, hobbies, ideas, even reactions and feelings: YOURS! The oneness in marriage is not similarity or sameness in matters relating to ideas or feelings but to the oneness of understanding. Any attempt to mold our mates in an effort to match them to our fantasies is arrogance on our part and an insult to them. While it is true that we can never mold or remake another person, we can 'allow' him to change."

The instruction on right living in Ephesians 4:2 can be applied to the marriage relationship. "Living as becomes you—with complete lowliness of mind (humility) and meekness (unselfishness, gentleness, mildness), with patience, bearing with one another and making allowances because you love one another" (Amplified). Look at the last part of the verse:

#### Differences in Marriage—The Potential for Growth and Enhancement

Yes, every person who marries has characteristics similar to the one he or she marries. But he or she also has many that are different. Different ways of perceiving, thinking, feeling, and behaving are part of marital adjustment. Differentness is important because it holds out the promise of need fulfillment for each person. It is important to remember that one of the main motivating factors toward marriage is the need to feel complete because of what the other person has to offer. Consciously or unconsciously people choose others who can help them feel complete. On the other hand, this innate differentness contains the seeds for hurt and disruption. Why? The answer is quite simple. We are threatened by the differences in our spouse. We are afraid that we might have to adjust our way of thinking and doing things. We also may

believe that "if it's different, it's wrong!" Many problems occur because of the lack of tolerance for differences of attitude or opinions in the marital relationship. You will be vaguely aware of differences when you marry. You certainly don't say now that your partner is different—more likely "unique." But after a while you will say ... different. At first you may try to accommodate. You tolerate, overlook, or deny differences to avoid conflict

Then you may try to *eliminate* the differences by demanding, pressuring, or manipulating your spouse.

But eventually you will learn to appreciate the differences because you discover that they are necessary and indispensable. And because of this you will be able to celebrate them. You delight in them. You welcome them. You encourage their growth. As you go through this process you will discover that you didn't marry the wrong person.<sup>8</sup>

Consider these thoughts: "In the midst of the marital struggle the honeymoon dream vanishes, and the despair over the old relationship comes up for reexamination. Suddenly each spouse turns his eyes away from the partner, and looks inwardly and asks, 'What am I doing to my partner? What is wrong with me? What am I misunderstanding? What must I do to rescue this marriage?' If honestly asked, the answers are not far behind: 'I really married my wife because of her difference. It is not my job to make her over, but rather to discover and to value that difference. But before I can do that I must accept my difference, and I really need her to help me discover my uniqueness. My task is not to mold her into a beautiful vase, but to participate with her to discover that beautiful vase even as we discover it in me. How arrogant of me to think I could shape another human being! How humble it makes me to realize

that I need to yield to another and thereby be changed! Our relationship will change both of us—in a process of being shaped into a form far more beautiful than either could imagine."

"We try to change people to conform to our ideas of how they should be. So does God. But there the similarity ends. Our ideas of what the other person should do or how he should act may be an improvement or an imprisonment. We may be setting the other person free of behavior patterns that are restricting his development, or we may be simply chaining him up in another behavioral bondage." <sup>10</sup>

In reality, we marry the right person—far more right than we can know. In a mysterious, intuitive, perhaps instinctive fashion we are drawn by both similarities and differences, by needs and anxieties, by dreams and fears to choose our complement, our reflection in another.

We always marry the right person, and the discovery of that rightness moves us into the third marriage within a marriage. We at last begin to appreciate what we had sought to eliminate.

As we discover that we knew more than we knew when we chose whom we chose, appreciation begins to break into a gentle flame. In appreciation, we discover that people who marry each other reflect each other. There is a similar level of maturity, a parallel set of self-understandings and self-acceptance in most couples choosing each other. The two express their self-image and self-valuation in the person selected.

People who marry each other complete each other in a puzzling yet pronounced way. The missing is supplied, the imbalanced is brought into equilibrium, the dormant is enriched

by what is dominant in the other.11

The adventure of marriage is discovering who your partner really is. The excitement is in finding out who your partner will become.

- How did you feel when you liked someone and that person didn't care for you?

- What is your favorite holiday, type of music, television program, and pastime?
- · What is your definition of an ideal spouse?
- · Who are the five most important people in your life?

- · Which Christian leaders or writers have influenced you?
- Where would you like to live? What country, state, city, house, and/or apartment?
- · What are your views on aging?
- · Describe the best year of your life.

#### Daily Log History Sheet

To assist you in becoming better acquainted with your potential partner, complete the following daily activity log with as much specific information as possible. It may be helpful to keep this with you at all times during a typical day. At the end of each hour, write down exactly what you did during that time. You will need to do this twice, once for a weekday and once for a Saturday.

- 1. When do you wake up?
- 2. When do you get up?
- 3. What steps do you take to get ready for the day? Example: Do you shower first or eat first? How much time do you need getting ready in the bathroom? How much time do you take preparing breakfast? Do you eat sitting down or on the run? Do you read the paper in the morning, have devotions, etc.? In other words, indicate your normal procedures and how much time you spend for each task.

- 4. As you drive to wherever you're going (work, school, etc.) do you enjoy the solitude or would you rather talk to someone? If you listen to the radio, what do you listen to?
- 5. Now that you've got the basic idea of what we're looking for, indicate what you do each hour of the day. Be sure to describe what you do on breaks, lunch, etc.
- 6. As you drive home, are you thinking about what went on during the day or what you're going to do in the evening? What do you enjoy doing for the first hour when you get home?
- 7. Describe in detail dinner preparations, what and where you like to eat, and what you do in the evening. When you get ready for bed, where do you put your clothes from this day? Do you prepare your clothes for the next day ahead of time or wait until the morning? Do you go to sleep with the radio or TV on? Do you like it completely dark and quiet or do you leave a light on?

Please feel free to add any details or any pertinent information that would help your partner have a better idea of your daily lifestyle. Be sure you follow the same procedure for your day off, such as Saturday. Once you have both completed these forms, share them with one another and discuss how

being married will change your daily procedure.


#### Final questions:

- If you are definitely bothered by the uniqueness of your fiance, ask yourself, "What would it be like being married to a person just like me—and would I like it?"
- 2. In what way will the presence of Jesus Christ in your life help you adjust to differences in your future marriage?

To assist you in fully discovering your uniqueness, as well as differences, ask your minister or counselor to administer the Myers Briggs Type Indicator (MBTI). You can save 20 years of frustration by discovering how God uniquely created you and how you can learn to be compatible with your spouse by using the MBTI to better understand your personality. It is the most accurate and insightful tool available to measure personality characteristics.

But it is important to expand your understanding by reading about who you are. A book designed to help you understand not only personality differences but gender differences and learning style differences as well is *How to Bring Out the Best in Your Spouse* by Gary Oliver and H. Norman Wright (Servant Publications). If you would like to become adept at relating to your fiance/spouse as well as your co-workers read *Type Talk* by Kroegger and Thuessen (Bantam Books) and *Mars and Venus Together Forever* by John Gray (Harper & Row),

especially Chapters 4–7. How to Bring Out the Best in Your Spouse contains an abbreviated form of the MBTI.

# Your Marriage Needs Three Types of Love— Eros, Philia, Agape

Eros is the love that seeks sensual expression. Eros is a romantic love, sexual love. It is inspired by the biological structure of human nature. The husband and wife, in a good marriage, will love each other romantically and erotically.

In a good marriage the husband and wife are also friends. Friendship means companionship, communication, and cooperation. This is known as philia.

Agape is self-giving love, gift love, the love that goes on loving even when the other becomes unlovable. Agape love is not just something that happens to you; it's something you make happen. Love is a personal act of commitment. Christ's love (and hence the pattern for our love) is gift love. Christ's love for us is sacrificial love. Christ's love is unconditional. Christ's love is an eternal love. Agape is kindness. It is being sympathetic, thoughtful, and sensitive to the needs of your loved one. Agape is contentment and agape love is forgiving love.

If individuals would put forth effort purposely to increase

philia and agape love, all three types of love would increase. The friendship love of philia can enhance and enrich both of the others. The agape love in turn can increase and enhance the others. Both agape and philia can enrich the eros love so it does not have to diminish as much as it usually does. It too can flourish if properly nurtured, and if so, the other types of love are reinforced. But all three must be given conscious effort

Your love will either live or die. What kills love? Love dies when you spend little or no time together and when you stop sharing activities that are mutually enjoyable. Love is created or destroyed by pairing or failing to pair the partner with pleasurable activities over a period of time. Love dies from failure on the part of both individuals to reinforce appropriate behavior in each other. Smiling, caressing, complimenting, showing compassion, and spending time together are behaviors in marriage that must be reinforced. If they are not reinforced they may disappear. If your partner stops doing things that you like, your love feelings may disappear.

### Something to Think About

Marital love requires the ability to put yourself in your partner's place, to understand that the differences that divide you are the differences of two unique personalities, rather than betrayals of your hopes and dreams. The unconditional willingness of each of you to understand and resolve these differences through the sharing of your deepest feelings, concerns, attitudes, and ideas is a fundamental component of marital love

Postponement of your need for instant gratification when your partner feels no such need; sharing the struggle to triumph over adversities as well as sharing the joys and delights of being together; nurturing each other in defeat caused by forces beyond your control and renewing each other's courage to prevail in the face of despair; carrying necessary obligations and responsibilities as a flower rather than as a hundred-pound knapsack; acknowledging the everyday value of your partner in a look, a smile, a touch of the hand, a voiced appreciation of a meal or a new hairstyle, a spontaneous trip to a movie or a restaurant; trusting your partner always to be there when needed; knowing that he or she always has your best interests at heart even when criticism is given; loyalty and dedication to each other in the face of sacrifices that may have to be made-all of these are additional components of marital love that courtship knows little about. 12

# What Do You Expect from Marriage?



Every person who marries enters the marriage relationship with certain expectations. These expectations come from many sources, including parents, values, society, books, speakers, and our own ideas. It is important to take the time to find out what these expectations are, which can be achieved, which are realistic, and how to handle them when things do not go according to plans. The word expectation carries with it the attitude of hope. Hope has been defined as "the anticipation of something good." Hope is necessary, as it motivates us and keeps us going.

This next exercise will take some thought and time on your part. Write 20 expectations you will have of your fiance when you are married. These can be simple or elaborate. For example, a husband might expect his wife to be at the door when he arrives home, always to be at home and never work, and to have sex with him whenever he wants it. A wife might expect her husband to go to her parents' house with her whenever she goes, to be the spiritual leader in their home, and to spend Saturdays at home and not out hunting.

Now, take your list of 20 expectations and share your list with your fiance. Take your fiance's list and read it to yourself. As you read each one of your fiance's expectations of you, place a check mark under the appropriate column. C stands for "cinch." You feel that the expectation you have just read is going to be a cinch to fulfill. S stands for "sweat." It will take some hard work and sweat but it can be done. N stands for "no way." You feel that the expectation is impossible. When the two of you have completed your evaluation of the expectations, give them back and then spend some time discussing them.

There are three very common expectations that couples have for their marriage. First, couples expect their marriage will work out and not end in divorce. This is an excellent goal, but what will be done to make it a reality? Write a paragraph indicating what you personally are bringing to this marriage that will make it work. When you and your fiance have done this, share your paragraphs together.

Another expectation couples have is fidelity. They expect that they will be faithful to each other. After all, infidelity as commonly conceived would be out of the question in a Christian marriage. Fidelity, however, involves not only sexual faithfulness, but other areas of faithfulness as well. For example, some spouses are unfaithful to their mate through their work. The center of attention, which belongs to their spouse, is given to their job. Some spouses are unfaithful to their mate through their mothers, fishing trips, golf, cars, church work, housekeeping, children, etc. You see, by putting any other person, possession, or activity (with the exception of your relationship with Jesus Christ) before your spouse, you could be unfaithful to the marriage relationship. What we need in marriage is creative fidelity. This means being sensitive to the needs of each other, supporting your partner, and being with him or her emotionally and physically.

Couples also expect their marriage to progress smoothly onward and upward without any major upheavals or adjustments. Consider the suggested outline of the three stages of marriage on the following page.

It has been suggested that most couples go through these three stages. What about you? Perhaps in your own relationship you have experienced some of the disenchantment stage already. Do you want to go through the full extent of the disenchantment stage as you see it expressed here? If not, then take some time to write out what you can do as an individual and what you can do as a couple to keep from going through

all of the experiences of this stage. When you have finished writing, share your responses together.

Often many of our expectations come from our own home and our own background. Complete the following statements and then share your responses with your fiance.

Change in marriage will happen. How will you adjust to it? Did you realize that even positive changes can disrupt a marriage relationship? A person who is married to a non-Christian and has prayed for many years for the spouse to accept the Lord suddenly discovers that his spouse has now accepted the Lord and has completely changed his lifestyle.

This upsets the Christian spouse. Why? An alcoholic man suddenly stops drinking and changes his lifestyle, which is what his wife has been asking for, but now she is upset. Why? A passive, submissive husband begins to assert himself in a positive way and becomes involved with the family and the children. His wife is a bit upset. Why?

Even though certain undesirable behaviors are occurring in a marriage relationship, the couple learns to adjust to them. But when one makes a positive change, it upsets the equilibrium and the spouse who has been asking for the change discovers that he (or she) must now change. He must learn to adapt to the person, which could be a bit uncomfortable. What he has been complaining about is no longer there, and now he must face himself and his own attitude and learn how to relate to this new person.

The one spouse may ask, "If he could change now, why did he wait so long and put me through all of this?" You might keep this in mind when you ask for change. Remember this: The best way to help another to change is to make changes in your own life. The other person may change as he learns to relate to the new you!

We can allow a

disappointment to hamper us, destroy us, and even destroy our marriage. But another response is to accept the disappointment, accept the hurt, discover what we can learn from it, and then make some new plans or alternatives. Read the following three passages of Scripture and write how you think these passages would help you accept and adjust to disappointments and change.

"Consider it all joy, my brethren, when you encounter various trials, knowing that the testing of your faith produces endurance" (James 1:2,3 NASB).

"In this you greatly rejoice, even though now for a little while, if necessary, you have been distressed by various trials, that the proof of your faith, being more precious than gold which is perishable, even though tested by fire, may be found to result in praise and glory and honor at the revelation of Jesus Christ" (1 Peter 1:6,7 NASB).

"Blessed is a man who perseveres under trial; for once he has been approved, he will receive the crown of life, which the Lord has promised to those who love Him" (James 1:12 NASB).

Look back at James 1:2,3. The word *count* or *consider* means "an internal attitude of heart and mind that causes the trial and

circumstance of life to affect a person either adversely or beneficially." The verb tense used here means that this is a decisiveness of action, not just a passive giving up or resignation. Another interpretation of this word could be "make up your mind to regard adversities as something to welcome or be glad about." It is an attitude of the mind.

The word *trials* means "outward trouble or stress, or disappointments, sorrow, or hardships." These are situations that you had no part in bringing about. They are not sin. They just happened. They include all of the various sorts of trouble that we have in our human life.

The word *endurance*, or *patience* as it is sometimes translated, means "fortitude" or "the quality of being stabilized or remaining alive." It is, in a sense, a picture of standing firm under pressure rather than trying to escape.

How will the presence of Jesus Christ in your life help you to fulfill your expectations of marriage and accept the ones that are not fulfilled?

### **FIVE**

# A Vision Statement



A good way to develop goals is to establish a "vision statement" for your marriage.

When you develop this vision statement:

- Be specific—A vision statement should have specific goals. Vague goals equal vague results. Quantify as much as possible.
- Be positive—A goal is something you want to have, not something you don't want, so focus on the positive.

There are many ways to think about vision. Vision could be described as *foresight*, with the significance of possessing a keen awareness of current circumstances and possibilities and of the value of learning from the past.

Vision can also be described as *seeing the invisible and making it visible*. It's having a picture held in your mind of the way things could or should be in the days ahead. <sup>14</sup>

Vision is also a *portrait of conditions that don't yet exist*. It's focusing on the future rather than getting bogged down by the past or present. Vision is the process of creating a better

future with God's empowerment and direction.

Vision is specific, detailed, customized, sometimes timespecific, and measurable. Vision is a way of describing the activity and development of a marriage. <sup>15</sup> The vision you have for your marriage may be different from any other person's. Having a vision for your marriage is having a realistic dream for what you, your spouse, and your marriage can become under God's direction. And we need to seek what God wants for us and our marriages because, without His wisdom, what we achieve may be out of His will. We need His wisdom because, "the Lord knows the thoughts of man; he knows that they are futile" (Psalm 94:11 NIV). <sup>16</sup>

Here is an example of the marriage goals developed by one married couple:

We will show more respect for each other. We will show interest in one another when we first meet at the end of the day. We will give each other at least one compliment a day. We will listen to one another without interruption even when we don't agree with what the other is saying.

We will improve our sexual relationship. We will read a book on sex aloud to each other and work toward making our sexual experience creative, satisfying, and exciting most of the time. We will both communicate clearly before 8:00 P.M. if we are interested in sex that evening. We will also be more verbal before and during lovemaking.

We will demonstrate our love more, both verbally and nonverbally. We will both ask how we can help the other each day. We will say "I love you" to each other at least once a day. We will make love at least once a week. We will

ask what the other wants to do on Friday and Saturday nights.

We will learn to be more flexible. We will learn to handle being a spontaneous guest for dinner, and spontaneously having guests for dinner.


We will see things from the other's perspective, giving ourselves two years to accomplish this. We will do a task the way our partner does it at least once before we encourage them to do it our way. We will work toward admitting when we're wrong and being less defensive.<sup>17</sup>

# SIX

# Fulfilling Needs in Marriage



One of the motivating factors for marriage is the fulfillment of needs in one's life. It is admirable to say that we are marrying the other person in order to help him fulfill his needs; but, to be very honest, we hope and believe that our needs will be met too. In marriage counseling we find that one of the major complaints couples bring in is that of not having their needs met. Often one partner is attempting to meet the needs of the other, but doesn't always know what the needs are or exactly how to meet them.

Thus we feel that it is important for a married person to define his needs specifically and then indicate how he would like his partner to respond in order to meet those needs. Some have asked, "Doesn't it take the romance out of marriage if you have to tell the other person exactly what you need?" Not really. In fact, it can increase the romance, since your spouse won't have to play the game of mind reading and try to figure out what you need and what you want!



Years ago a psychologist named Abraham Maslow suggested that each person has certain basic needs in his or her life. He listed these needs in order of importance. First, a person seeks to fulfill his or her physiological needs. These are those things that are necessary in order to sustain life: food, water, oxygen, rest, etc. Second, a person seeks to fulfill safety needs, which involve the need for a safe environment, protection from harm, etc. Third, after having the first two sets of needs fulfilled, a person seeks to fulfill his or her need for love and belonging. This includes a desire for affectionate relationships with others. Fourth, a person seeks to fulfill his or her need for esteem. Esteem involves receiving recognition as a worthwhile person. Finally, after the other levels of needs are met, a person seeks to fulfill the need of self-actualization. This is the need to become the person one has the potential to become, to develop into a full, creative person.

#### Maslow's Levels of Needs

Most husbands and wives help to fulfill the first two levels of needs in each other—the physiological and safety needs. Most husbands, for example, allow their wives enough air, water, food, and rest. And most are concerned about keeping the car in good running order, making sure the house is safe

with proper lighting, ventilation, locks, and so on. But where most husbands and wives fall down is in meeting their spouse's needs for love and belonging, esteem, and self-actualization.

Within this classification of needs the word esteem or selfesteem has arisen. This concept of self-esteem or self-image is one of the most important foundations of marriage. If one marries with a low self-esteem, a strain can be placed upon the marriage. You may be marrying in order to build your selfesteem or seeking to have your spouse give you a sense of meaning.

Our self-image or self-concept is often built upon our appearance. We ask, "How do I look?" Is your self-concept built upon your appearance? It is also built upon the following. To what degree does your self-concept depend on each of these? Write your responses.

1. Status: feeling important

2. Belongingness: being wanted or accepted

3. Worthiness: feeling worthwhile or valuable

4. Competence: feeling adequate

Let's look specifically at the last three. Belongingness rests on the voluntary attitude of others as they display their acceptance. It is a sense of security with others who love and accept you. Your fiance probably accepts you, but what happens during times when you feel a lack of acceptance? Worthiness rests on the introspective attitude of self-approval and being affirmed as a person of value. What happens when you don't feel that you approve of yourself?

Competence rests on the evaluations received in past relationships and on one's present sense of success. What happens when you don't feel successful or when you're not?

Think about this: Your worth is so great that if you had been the only person created upon the earth, God still would have sent His Son to die for you. You count that much to Him Many of us strive for adequacy. God has declared us to be adequate in what He has done for us in His Son Jesus Christ.

In your relationship with God you are assured of belongingness. In your relationship with the Son of God you are assured of worthiness. In your relationship with the Holy Spirit you have a secure sense of competence as He is our Comforter, Guide, and Source of Strength.

How will the presence of Jesus Christ in your life help you fulfill your needs and those of your spouse? How will His presence help you build your self-worth?

# **SEVEN**

# Roles, Responsibilities, and Decision Making



What about the question of roles and responsibilities in marriage? Who does what and why? Does he or she do it? Is it because of tradition or because of what the church has said? Or is it because that is the way it was done in your parents' home?

Failure to clarify the husband/wife roles in a relationship is a major cause of marital disruption. As a couple you will be involved in an almost endless number of activities and responsibilities. Each couple should discuss together and decide who is most competent to do each task. Tasks should not be assigned on the basis of parental example, the expectations of your social group, or tradition. When an individual's abilities, training, and temperament make it difficult or unnecessary to follow an established cultural norm for a role, the couple will need to have the strength to establish their own style of working together. It is imperative that a couple deliberately and mutually develop the rules and guidelines for their relationship as husband and wife. This clear assignment of authority and responsibility does not create a rigid

relationship but allows flexibility and order in what could become a chaotic mess.

Let's spend some time now thinking about your role as a wife or husband.

#### "Woman's Place-Where Are You?"

Property—wife has almost no rights and privileges compared to those of the husband. Husband is the family provider. Often the wife is merely a chattel for the husband's sexual expression.

Complement—wife's rights have increased. Marriage is the wife's central life interest. Husband is chief provider and has more authority than wife. She is a friend to her husband. He achieves and she supports him.

Junior Partner—wife's rights increase because she works outside the home for pay. Her main motive is to improve the family's lifestyle. She has more authority (rights) than a nonworking woman.

#### Decision Making

Consider these thoughts about the roles of the husband and wife in decision making: "The principle of mutuality of submissiveness in marriage is similar to the pattern of submissiveness between the members of the Body of Christ.

6. I want my fiance to make decisions in the area of ...

There are times in the Body when it is appropriate for one member to exercise leadership over the other members as a function of his or her spiritual gift (1 Corinthians 12:14-26). No single spiritual gift automatically qualifies a member to be the leader or ultimate decision maker all of the time. That position belongs to the head, Jesus Himself. Likewise in marriage, in which there is mutuality of submissiveness, the role of leadership is assigned not according to some decree from God, or on the basis of 'maleness' or 'femaleness,' but on the basis of the leadership role the partner has been assigned by the mutual decision of the marriage. The skill of a Christian marriage lies in the negotiation and assignment of these leadership roles on the basis of the abilities of the partners." <sup>19</sup>

"In the marriage the husband has the office of head. That simply means he has the responsibility and authority to call the marriage—his wife as well as himself—to obey the norm of troth. If he faithfully exercises his office, both he and his wife will be freed to be themselves. As the head, the husband is called to take the lead in mutually examining the marriage to see if it is developing according to its long-range goals.

"Clearly, headship has nothing to do with being boss. The husband can only command the wife to live up to what the two of them mutually pledged when they were married. Likewise, if the husband neglects his office, the wife ought to call the husband back to their mutual vows.

"Neither does headship imply inferiority or superiority. Rather, headship is a special office of service so that the marriage may thrive and grow. Headship does not mean that the husband leads or decides in every detail. Once a

man and woman have decided which vision of life is going to norm their activities in their marriage, they can leave the decisions in day-to-day affairs to the partner with the appropriate talents, temperaments, and situations. The husband's role is to be on guard continually so that the 'little' things do not develop into the kinds of patterns that undermine the entire marriage."<sup>20</sup>



#### **NINE**

### Communication



Communication is to love what blood is to life. Have you ever thought about it in that way before? It is impossible to have any kind of relationship unless there is communication. That is true for you and your fiance and for your relationship with God.

How would you define *communication?* What do you think the word means? Write your definition and then share your answer with your fiance.

Now define listening and again share your definition.

At this point you may want to turn to the end of this section and read a definition of communication and a definition of listening. How important is communication? Think about this.

"If there is any indispensable insight with which a young married couple should begin their life together, it is that they should try to keep open, at all cost, the lines of "A marriage can be likened to a large house with many rooms to which a couple fall heir on their wedding day. Their hope is to use and enjoy these rooms, as we do the rooms in a comfortable home, so that they will serve the many activities that make up their shared life. But in many marriages, doors are found to be locked—they represent areas in the relationship which the couple are unable to explore together. Attempts to open these doors lead to failure and frustration. The right key cannot be found. So the couple resign themselves to living together in only a few rooms that can be opened easily, leaving the rest of the house, with all its promising possibilities, unexplored and unused.

"There is, however, a master key that will open every door. It is not easy to find. Or, more correctly, it has to be forged by the couple together, and this can be very difficult. It is the great art of effective marital communication." <sup>22</sup>

Let's consider another aspect of communication. In our communication we send messages. Every message has three components: the actual content, the tone of voice, and the nonverbal communication. With changes in the tone of voice or in the nonverbal component, it is possible to express many different messages using the same word, statement, or question. Nonverbal communication includes facial expression, body posture, and actions. An example of nonverbal communication which should be avoided is holding a book in front of one's face while talking.

The three components of communication must be complementary. One researcher has suggested the following breakdown of the importance of the three components. <sup>23</sup> The percentages indicate how much of the message is sent through each one.

Content / 7%

Tone / 38%

#### Nonverbal / 55%

Confusing messages are often sent because the three components contradict one another.

Take a minute and think about how you communicate nonverbally. Then write how your fiance communicates nonverbally. After you have done this, write what you think your nonverbal communication means to the other person and what you think your fiance's nonverbal communication means. Ask your fiance to do this too, and then compare and discuss your responses.

Our nonverbal communication and tone of voice are essential elements in conveying our messages. If you are not aware of your tone of voice, you may want to use a tape recorder to record some of your conversations. Then play them back and pay attention to your tone of voice and what it implies.

Let's see what kind of communicator you are and discover how much you know about your fiance. Imagine that you are interviewing a stranger. Your task is to ask the other person any question you want about marriage, dating experiences, childhood, hobbies, likes and dislikes, religious views, feelings about himself, his looks, etc. Keep in mind that you know nothing about the other person. Construct your questions so that you assume nothing. Keep your opinions out. When you have completed the interview, change roles and have your fiance interview you.

In his book Why Am I Afraid to Tell You Who I Am? John Powell states that we communicate on five different levels, from shallow clichés to deep personal sharing. Hang-ups, such as fear, apathy, or a poor self-image keep us at the shallow level. If we can be freed from our restrictions, we can move to the deeper, more meaningful level.

The five levels of communication are:

Level Five: Cliché Conversation. This type of talk is very safe. We use phrases such as "How are you?" "How's the dog?" "Where have you been?" "I like your dress." In this type of conversation there is no personal sharing. Each person

remains safely behind his defenses.

Level Four: Reporting the Facts About Others. In this kind of conversation we are content to tell others what someone else has said, but we offer no personal information on these facts. We report the facts like the six o'clock news. We share gossip and little narrations, but we do not commit ourselves as to how we feel about them.

Level Three: Ideas and Judgments.

Real communication begins to unfold here. The person is willing to step out of his solitary confinement and risk telling some of his ideas and decisions. He is still cautious. If he senses that what he is saying is not being accepted, he will retreat.

Level Two: Feelings or Emotions.

At this level the person shares how he feels about facts, ideas, and judgments. His feelings underneath these areas are revealed. For a person to really share himself with another individual he must move to the level of sharing his feelings.

Level One: Complete Emotional and Personal Communication. All deep relationships must be based on absolute openness and honesty. This may be difficult to achieve because it involves risk—the risk of being rejected. But it is vital if relationships are to grow. There will be times when this type of communication is not as complete as it could be.<sup>24</sup>

Persons who communicate primarily on a cognitive or thinking level deal mainly with factual data. They like to talk about such topics as sports, the stock market, money, houses, jobs, etc., keeping the subject of conversation out of the emotional area. Usually they are quite uncomfortable dealing with issues that elicit feelings, especially unpleasant feelings such as anger. Consequently they avoid talking about subjects that involve love, fear, and anger. These persons have difficulty, then, being warm and supportive of their spouses.

Others communicate more on the feeling level. They tire easily of purely factual data and feel a need to share feelings, especially with their spouses. They feel that the atmosphere between husband and wife must be as free as possible from unpleasant feelings like tension, anger, and resentment. So, of course, they want to talk about these emotional things, resolve

conflicts with their spouses, clear the air, and keep things pleasant between them.

Of course no one is completely cognitive or completely emotional. Where are you and where is your fiance? On the diagram below indicate (1) where you think you are, (2) where you think your fiance is, and (3) where you think your fiance would place you.



## **Emotional**

## Cognitive

A person on the left side of the graph, who shares more feelings, is not less bright or less intellectual. This person is simply aware of his/her feelings and is usually better able to do something about them.

Surprisingly, the so-called cognitive person (on the right) is controlled by his feelings just as is the so-called emotional person, but he doesn't realize it. For example, the stiff, formal intellectual has deep feelings also, but uses enormous energy to keep them buried so he won't be bothered with them. Unfortunately they do bother him. Whenever someone (like an "emotional" wife or child) is around asking him for affection and warmth, he might be unable to respond and angered that his equilibrium has been disturbed. 25

Communication is the process of sharing yourself, both verbally and nonverbally, in such a way that the other person can both accept and understand what you are sharing.

What is listening? Paul Tournier said, "How beautiful, how

grand and liberating this experience is, when people learn to help each other. It is impossible to overemphasize the immense need humans have to be really listened to. Listen to all the conversations of our world, between nations as well as those between couples. They are, for the most part, dialogues of the deaf."<sup>26</sup>

The Living Bible expresses these thoughts about listening:

"Any story sounds true until someone tells the other side and sets the record straight" (Proverbs 18:17).

"The wise man learns by listening; the simpleton can learn only by seeing scorners punished" (Proverbs 21:11).

"He who answers a matter before he hears the facts, it is folly and shame to him" (Proverbs 18:13, Amplified).

"Let every man be quick to hear (a ready listener) ..." (James 1:19 Amplified).

What do we mean by listening? When we are truly listening to another person we are not thinking about what we are going to say when he stops talking. We are not busy formulating our response. We are concentrating on what is being said. Listening is also complete acceptance without judgment of what is said or how it is said. Often we fail to hear the message because we don't like the message or the tone of voice. We react and miss the meaning of what was being shared.

By acceptance, we do not mean agreeing with everything that is being said. Acceptance means understanding that what the other person is saying is something he feels. Real listening means that we should be able to repeat both what the other person has said and what we thought he was feeling when he was speaking to us.

It is important to become proficient in communication. You may want to read *How to Bring Out the Best in Your Spouse* (Servant Publications), *chapters 4–9*, by H. Norman Wright and Gary Oliver.

# Conflict (or "Sound the Battle Cry!")



A re you anticipating conflict in your marriage? If not, you may be in for a surprise. Conflict is a fact of life. It has been defined as a clash, contention, or sharp disagreement over interests, ideas, etc. Why does conflict occur? The answer is simply that we are human beings—imperfect people whom God graciously loves in spite of our imperfection. Each of us has our own desires, wants, needs, and goals. Whenever any of these differ from those of another, conflict may occur. Our beliefs, ideas, attitudes, feelings, and behaviors will be different. The differences themselves are not the problem, but rather our reaction to them.

Many times disagreements or conflicts do not need to be completely resolved. An example may be a disagreement over political philosophy. This type of disagreement could continue indefinitely and need not destroy the overall marital relationship.

## What causes conflicts? See James 4:1-3.

Remember: Conflict is a natural part of growth and family living. Many conflicts are simply symptoms of something else. Most people do not deal openly with conflict because no one has ever taught them effective ways of dealing with it. On the positive side, conflict does provide opportunity for growth in a relationship. Unresolved and buried conflicts arise from their grave and interfere with growth and satisfying relationships.

What choices do we have in dealing with conflicts? James Fairfield has suggested five styles of dealing with conflict.<sup>27</sup>

The first is to withdraw. If you have a tendency to view conflict as a hopeless inevitability that you can do little to control, you may not even try. You may withdraw physically by leaving the scene or you may leave psychologically.

If you feel that you must always look after your own interests or your self-concept is threatened in a conflict, you may choose to win. No matter what the cost, you must win! Domination is usually reflected in this style; personal relationships take second place.

"Giving in to get along" is another style. You may not like it, but rather than risk a confrontation you choose this path.

"Give a little to get a little" is called *compromise*. You may find that it is important to let up on some of your demands or

ideas in order to help the other person give a little. You don't want to win all the time nor do you want the other person to win all the time.

A person may choose to resolve conflicts. In this style of dealing with conflicts, a situation, attitude, or behavior is changed by open and direct communication.

As you can see from the diagram above, withdraw has the lowest value because the person gives up on meeting the goals and developing the relationship. The relationship is turned off. If this style is used temporarily as a cooling off step toward resolve, it is beneficial. There may be times when the discussion is so heated and out of control that withdrawing is best. But it is important to make a definite and specific commitment to discuss and resolve the conflict.

The win method achieves the goal but can sacrifice the relationship. In a family, personal relationships are just as important or more important than the goal.

*Yielding* works just the other way in that the relationship is maintained but the goals are sacrificed.

Compromise attempts to work out some needs but the bargaining involved may mean that you compromise some of

your own values. If you have some basic convictions about the type of young men that your daughter dates and you begin to compromise your standards in order to have greater harmony, what does that do to you?

Naturally the highest value or style is *resolve* because in the final analysis relationships are strengthened as you seek to meet personal needs.

How then can we resolve conflicts? Consider trying and applying these principles: 1. When a conflict arises, instead of demanding that you be heard, listen carefully to the other person (see Proverbs 18:13 and James 1:19). Any changes that one person wants to see in another must be heard and understood

- Select an appropriate time. "A man has joy in making an apt answer, and a word spoken at the right moment, how good it is" (Proverbs 15:23 Amplified).
- 3. Define the problem. How do you define the problem and how does the other person define it?
- Define the areas of agreement and disagreement in the conflict.
- 5. Here comes the difficult part. A few conflicts may be just one-sided, but most involve contributions from both sides. Identify your own contribution to the problem. When you accept some responsibility for a problem, the other sees a willingness to cooperate and will probably be much more open to the discussion.
- 6. The next step is to state positively what behaviors on your

part would probably help, and to be willing to ask for the other person's opinion. As they share with you, be open to their feelings, observations, and suggestions. Watch out for defensiveness!

# **Finances**

Money! It takes money to eat and to pay the rent, the tax collector, the grocer, etc. Your attitude toward money and past lifestyle may be an adjustment for you when you marry. Financial disruption and difficulties in marriage can place a strain upon the marital relationship. The next several exercises have been designed to help you determine what is important to you in terms of finances and help you make some realistic plans.

First, let's see how aware you are of how much items cost today.

"You paid how much for that?"

Secret thoughts of a husband: "I just can't understand why my wife is always short of money. Now if I took over, things would be more efficient and there would be money to spare."

A wife broods: "I don't know why my husband says he can't take me out more often. His expenses aren't that high."

Do you confess to thinking like that occasionally? Here is your chance to show how much you know about the day-to-day money problems your fiance will face. This quiz is divided into two sections, one for each partner. Each of you is asked to approximate the cost of twenty items or services that the other

will probably pay for. Here are the rules: Women ask their husbands-to-be the questions headed "For Men." Men ask their wives-to-be the questions headed "For Women." In some cases a price range rather than the approximate cost may be allowed.

Score four points for each correct answer. Don't be too strict. Give your fiance credit for a correct answer if he or she comes within, say, 10 percent of the right amount.

If you want to compare scores, go ahead. But that's not the point of the quiz. The idea is simply to show how well you understand your partner's expenses. And maybe the quiz will teach you a lesson: Don't beef about somebody's spending habits until you know what you are talking about.

### Money and Control

Money can be used as power. People can use it to manipulate others or show a lack of trust without any reasonable cause. For example, one partner can demonstrate distrust by closely questioning all the receipts of the other. This is not how to start a marriage.

#### Money May Be Your Source of Status

Money can also be used as a source of status or self-esteem. It's called "trying to keep up with the neighbors." It's the way that some people gain their identity. You probably can't afford to play this type of game. It does not give you what you want, and it costs too much money.

#### The Problem!

The *shop-a-holic*—This is someone who overspends in a compulsive way. This isn't careful shop-the-sales type buying, but an uncontrollable impulse buying habit. Take the following shop-a-holic test.

#### Dos and Don'ts for Budgeting

 Plan your budget together. Hold a definite date together seek agreement and cooperation. Make decisions together. Figures and plans should be known by both of you.

- 3. Don't rush into a budget before you know how much you now spend for what. Devote several weeks to keeping a detailed expense record for use in working on a budget. If you do not know where your money is going, you cannot sensibly decide where it should go.
- 4. Do not think up countless budget headings. Use common sense in approaching and clarifying and classifying according to your family's spending habits.
- 5. Divvy up your dollars according to your family's needs and wants. Do not allocate according to the way other people spend. Use averages, canned guides, and other outside advice as rough starting points only. Indicate your specific needs and wants:

# Needs

### Wants

6. Think first. When allocating, trimming, or adjusting budget amounts, do not jump to conclusions. Do not let wishful thinking take the place of sober appraisal. Does an expense item look too high? Find out whether it really is high, or why it is high, before cutting it. If you are looking for a place to economize so you can spend more on something else, do not cut arbitrarily. Before you do whittle down an item, spell out precisely what specific items of past expenditures are to be reduced or eliminated.

- Take all credit cards—except one for emergencies—out of your wallet. Cancel multiple Visas and MasterCards. Don't let them become a way of financing your daily living.
- 8. Don't carry your checkbook or debit card around. Write

yourself one allowance check every week ... for lunches, newspapers and magazines, groceries, dry cleaning, and laundering. Cash the check—and don't spend more than that for those expenses during the week. Become your own banker, and learn how to say no.

- 9. Plan for the big expenses. You can expect several big, non-recurring expenses during the year—taxes, insurance, vacation bills, etc. Forecast those expenses and put aside an amount each month to meet the expenses when they come due. If not planned for, a few of these expenses will throw your budget into chaos, from which it may never recover.
- 10. Know who is in charge of what. Each member of the family should know just what his or her responsibilities are.
- 11. Experiment. For two months, write down every penny you spend. When you buy a candy bar from the vending machine at work, write it down. When you write your mortgage check, note it in the book. At the end of each of the two months, review your expenses and label them "O" for optional and "E" for essential. The challenge is to eliminate the optional expenses that give you the least value for your money.
- 12. Except for the above experiment, do not keep track of every

penny. Each member in the family should be allowed to spend his allowance as he chooses, without having to make an entry in the budget. Do not insist that everyone keep itemized lists of all expenses. Do not demand detailed accounts and summaries of one another.

- 13. Do not intermingle funds. Do have a clear-cut system for divvying up the paycheck. A checking account is a good system. You deposit a sum of money each payday to cover expenses, keeping record of how much is earmarked for what. This way you will not be spending more than you have allotted for any one budget item.
- 14. Do not cheat your budget. For example, if your budget shows you cannot afford a new ski outfit this month, do not go out and charge it. A debt like this should always be taken into account for next month's planning. Otherwise, you will find that a substantial amount of your funds has already been spent because of the charge.
- 15. Use automatic deduction. No matter how strapped for cash you feel you are, authorize automatic deductions from your salary for 401(k) savings or other company retirement programs.
- 16. Don't carry around too much cash—you will tend to spend

- it. Automated teller machines (ATMs) have become a convenient source of impulse cash for many people. Try to go to your ATM only as planned, not to pocket an extra \$100. If you face an emergency, fine. But don't run to the machine just to buy an unbudgeted item on sale nearby.
- 17. Avoid shopping retail. There's no reason to pay an outrageous markup on retail items when outlet shops offering tremendous discounts might be less than 30 minutes from your home. You can pick up a local outlet guide at a bookstore.
- 18. When the budget starts to rub tight, let it out here, tuck it in there, to give a better fit. Do not keep it ironclad and inflexible. A grim, unbending budget will soon make everybody sullen, if not outright mutinous. A good rule of evaluation is to look at your budget every January and every July to make certain that it is realistic and working for you to your benefit.
- AND ... do not quit at the first chance you get. Budgets seldom click the first time around. Hang on, start revising, try fresh starts. Do not toss in the towel. If at first you don't succeed, you know what to do!<sup>29</sup>

As you make out your budget be sure to insert an item designated "Marriage Enrichment." This amount, which could be from \$50 to \$250 per year, is set aside for you to use for the enhancement of your marriage relationship. It can be used for books to read together, tapes to listen to together, honeymoon

weekends, marriage enrichment retreats, etc. By doing this and planning this as a goal you should be able to build the quality of married life that you are both seeking at this time. But it doesn't just happen! It takes planning and work.

How will the presence of Jesus Christ in your life help you with the financial aspect of your married life?

# Sex in Marriage



The Bible talks about four specific purposes for human sexual activity: procreation, recreation, communication, and release. Look into what God's Word says about each of these purposes by reading the following Bible verses and talking over the discussion questions.

Show me how I can help them.

Thank you, Lord, for making me a sexual being.

Thank you for showing me how to treat others with trust and love.

Thank you for letting me talk to you about sex.

Thank you that I feel free to say:

"Thank God for sex!"31

The material in this section on sexuality is simply an introduction. It is very important that you be fully informed of both the physiological and biblical facts concerning sex. The vast majority of individuals are not nearly as informed as they could be, and, surprisingly enough, women are more informed in most cases than men. Prior to your marriage it is highly recommended that you listen to the cassette series Before the Wedding Night by Dr. Ed Wheat, a Christian medical doctor. In addition, the book entitled Getting Your Sex Life Off to a Great

#### **THIRTEEN**

# Your Spiritual Life Together



Spiritual intimacy. What's that? Spiritual intimacy is a heart's desire to be close to God and submit to His direction for your lives. It is the willingness to seek His guidance together, to allow the teaching of His Word in your everyday life. It's a willingness to allow God to help you overcome your discomfort over sharing spiritually and learn to see your marriage together as a spiritual adventure. It's a willingness to enthrone Jesus Christ as Lord of your lives and to look to Him for direction in your decisions, such as which house to buy, where to go on vacations, or which school is best for the children. It means He will direct both of you, and change your hearts to be in agreement rather than speak just through one of you.

### Lordship and Control

Spiritual intimacy in marriage requires both partners to submit to the leadership and lordship of Christ, instead of competing for control. One author wrote: We can gather all facts needed in making a decision. We can thresh out our differences as to the shape and direction our decision should take. We can put off the decision while we allow the relevant information to simmer in our minds. Even then, however, we may be uneasy; we still don't know what is best to do, and the

right decision just won't come.

When we turn to the Lord Jesus Christ and open our consciences to His Spirit's leading, some new events, remembrances, and forgotten facts will come to us. A whole new pattern will emerge. We can then move with abandon in a whole new direction which we had not previously considered. Looking back, we may conclude that God's providence delivered us from what would have been the worst possible decision. Jesus as Lord made the difference between deliverance and destruction.<sup>32</sup>

For a couple to have spiritual intimacy they need shared beliefs as to who Jesus is and the basic tenets of the Christian faith. You may have different beliefs about the second coming of Christ, or whether all the spiritual gifts are for today or not. One of you may enjoy an informal church service while the other likes a high church formal service, or one of you may be charismatic and the other not. There can still be spiritual intimacy within this diversity.

We hear about mismatched couples when one is a Christian and one isn't. You can also have a mismatch when both are believers but one wants to grow, and is growing, and the other doesn't and isn't.<sup>33</sup>

A wonderful way to encourage spiritual intimacy is to share the history of your spiritual life. Many couples know where their spouses are currently, but very little of how they came to that place.

Use the following questions to discover more about your partner's faith:





#### A Marriage Benediction



May your marriage bring you all the fulfillment a marriage should bring and may the Lord give you patience, tolerance, and understanding. May it be full of joy and laughter, as well as comfort and support. May you discover the true depth of love through loving one another.

Remember that every burden is easier to carry when you have the shoulders of two instead of one. When you are weary and discouraged, look to Jesus to refresh and strengthen you.

May you always need one another—not so much to fill your emptiness, as to help you to know your fullness. May you always need one another, but not out of weakness. Rejoice in and praise one another's uniqueness, for God is the Creator of both male and female and differences in personality.

Be faithful to one another in your thoughts and deeds and, above all, be faithful to Jesus. May you see the marriage bed as an altar of grace and pleasure. May you remember that each time you speak to one another you are talking to someone that God has claimed and told, "You are very special." View and treat your partner as one who was created in the image of God. Remember that you are not to hold your partner captive, but to give them freedom to become all that God wants them to be. May you then embrace and hold one another, but not encircle one another.

May God renew your minds so you look to draw out the best and the potential in one another. Look for things to praise, never take one another for granted, often say, "I love you," and take no notice of little faults. A ffirm one another, defer to one another, and believe in your partner. If you have differences that push you apart, may both of you have good sense enough to take the first step back. May the words, "You're right," "Forgive me," and "I forgive you" be close at hand.




